

Q1 Are you a resident of Killarney


Q2 What Ward do you live in?













Q9 If backyard hens were to be allowed, how many hens should be allowed per property?





Q10 How many Backyard Hens should be allowed on properties less than 0.5 acres





Q11 How many Backyard Hens should be allowed on properties between 0.5 and 1 acre?





Q12 How many Backyard Hens should be allowed on properties between 1 acre and 5 acres?







In my opinion, if someone wants to raise backyard hens, it must be on a large property a good distance away from neighbours.

This is a good idea for personal use, this should not require large numbers of hens. Also there will be a cost to enforcing compliance with the rules around these hens, has this been accounted for in budgeting?

Hens are very sociable creatures... if they are kept well in a clean space/ shed and can walk around outside in small groups I find it a pretty, lively picture of "old fashioned, historical tradition, especially of Killarney! Of course neighbors concerns should always be respected. And therefore the property size should always limit the amount of animals kept.

I would be concerned about the smell for close neighbours as well as the noise especially if roosters are involved.

Unless someone has a heated shed they need 40 or probably more hens to keep them all from freezing. You must have electrical in the shed to provide light on a daily basis or they won't produce eggs if that's what you're trying for. Meat hens are a different breed of course. What are people going to do with mountains of uncomposted smelly shit full of partially digested seeds that are attracting huge numbers of rats etc? How many neighbour disputes will result? People who advocate for hens inside the residential area likely know NOTHING about keeping hens.

So long as the animals are being cared for I personally have no issue with residents keeping hens on their property. I live close to someone who has some and they pose no disturbance.

I think it is a great idea to allow backyard hens also I think doing a survey like this is a great way to communicate with the citizen of Killarney
